Freedom of Information: Right to know request

Thank you for your request dated 4 November 2019 under the Freedom of Information Act 2000 (the Act), for information relating to the gender split for each controlled function by industry. For full details of your request, please see Annex A.

Your request has now been considered and we can confirm we hold the information you have requested.

The figures provided below show the number by gender performing regulatory functions (APER / SMR / SIMF) under each of the seven sectors. Where an individual may hold more than one regulatory function in a sector they have been counted once per sector. However, where a firm operates in more than one sector, individuals in this scenario will be counted once in each sector, e.g. Individual A holds three functions for Firm B, Firm B operates in only one sector therefore the individual will be counted once in that sector. Individual C holds three functions for Firm D which operates in four sectors therefore the individual will be counted once in each sector.

The following data outlines the total number of regulatory functions held by gender across each sector as per the search requirements of Mr, Mrs, Miss, Ms for the year end 31 December 2018 and as at 4 November 2019.
